## **SECTION 1**

- 1. The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to qualify for the award of the contract and also inspect the site before bidding.
- 2. Time allowed for completion of each package is 12 months, including the rainy season. If the size of the package is greater than 10 Crore then Construction / Time of completion shall be enhanced from 12 Months to 18 Months.
- 3. Earnest money pledged in favour of Executive Engineer of the concerned Division as mentioned in Bihar Financial Rule. For work costing more than one crore, Bank Guarantee from any scheduled bank in the state is applicable (If issued from any scheduled bank outside state then it will be converted to any scheduled bank within the state of Bihar before executing the work agreement).
- 4. The bids shall remain valid for acceptance for a period of 90(ninety) days from the last date of submission of bids. Bids once submitted cannot be withdrawn. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
