Contractor registered with Central Government/ any Other State Government of any PSU or an agency of national repute may participate in e-tender without the registration. However, registration with the Rural works department will be essential after issue of L.O.A. and before executing the agreement.

Following documents are required at the time of submission of bid (in case of other State PWD/CPWD/ any PSU cligible contractors or Agencies of National repute following documents from a to d have to be submitted after letter of acceptance.

- (a) Registration paper (Online) of appropriate class in RWD dept.
- (b) GST registration in State of Bihar.
- (c) Character Certificate dully issued by competent Authority subject to validity.
- (d) Latest labour license (renewed) in State of Bihar.
- (e) Duly pledged EMD
- (f) Bank Draft for B.O.Q. cost
- (g) Pan Card
- (h) Evidence of access to line of credit.
- (i) Affidavit regarding correctness of certificate.
- (j) Affidavit regarding no relation certificate.
- (k) Annual Turnover Certificate form Charted Accountant for last five Financial Years forms with break of civil works & total works each financial years.
- (l) Power of attorney/ Partnership deed/ MOU of private limited company
- (m) Tools & plants ownership/lease certificate required in aforesaid work duly verified from Divisional Engineer (Other State PWD/ CPWD Contractor will provide definite proof from appropriate authority for tools & Plant and Undertaking to install it on works site after getting letter of acceptance). If tools and plants are on lease then the list of work load of lease provider.
- 5. Evaluation & qualification criteria to qualify for the award of the contract are according to SBD clauses. Before uploading tenders, bidders are advised to go through SBD conditions. Agreement shall be drawn with the successful tenderer on SBD (Standard Bidding Documents).
- 6. Contractors shall attach scanned copies of all required papers, D.D. and certificates as required in the eligibility criteria. All the upload documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates only. The bidders should satisfy themselves of Download ability/visibility of the scanned & uploaded file by them.
- The amount of Estimated Cost or B.O.Q. Cost of the work may vary & The earnest money will be applicable on the sanction cost of B.O.Q. only.
- 8. Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer, R.W.D. Works Division Pupri except on Sunday and Public Holidays. All these documents can be download from the website http://pmgsytendersbih.gov.in directly.
- Earnest money should be as per Bihar PWD code. The said instruments shall remain valid for the minimum 45 days beyond validity of bid.
- 10. The Contractor shall be required to deposit an amount equal to 2% of the tendered value of the work as performance guarantee in including earnest money in the form as mentioned in Bihar Financial Rules.
- 11. Bid validity period is 120 days.
- 12. The description of the work is as follows:-

Copies of other drawings and document pertaining to the works will be open for inspection by the tenderes at the office of the above-mentioned officer. Tenderers are advised to inspect and examine

the site and its surrounding and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he ispects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tool & Plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates as which stores, tools and plant, etc. will be issued to him by Government and local conditions and other factors having a bearing on the execution of the work.

- 13. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 14. The competent authority on behalf of Governor of Bihar reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall bound to perform the same at the rate quoted.
- 15. The Department has right to cancel or postpone any work without given any notice or clarification.
- 16. Any objection about technical bid will be consider if submitted in C.E.-3 office within 5 working day.
- 17. The Department may add or delete any of the condition required for execution of any work.
- 18. This Notice Inviting Tender shall form a part of the contract document. The successful tenderer/contractor, the Competent Authority, Shall issue the letter of acceptance and will sign the contract after submitting the performance guarantee within 15 days:-
 - (a) The notice inviting tender, all the documents including additional conditions specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
 - (b) S.B.D. (Standard Bidding Documents).
- 19. A set of bidding documents will be available online on website htt://pmgsytendership.gov.in. Cost of bid document non-refundable will be deposited in the form of demand draft of any schedule bank in favour of the Executive Engineer, Rural Works Department, Works Division Pupri.
- 20. Instrument of Bid Security in (in the form of Bank Guarantee or Fixed Deposit Receipt or in any other forms as specified in the bidding document) of the amount specified for the work in the table shall be valid for 45 days beyond the validity of the bid. Scanned copy of the instrument of this affidavit shall be submitted online as part of Contractor's documents.
- 21. Required affidavits along with Original Demand Draft of Cost of Bid Document in the form of DD and Bid Security shall be placed in an envelope and must be submitted at the office of Chief Engineer-3, Bihar Rural Roads Development 2nd floor Vishweshwaraiya Bhawan, Patna/ S.E., Rural Work Department, Circle, Sitamarhi/ Executive Engineer, Rural Work Department Works Division, Pupri either by registered post or by hand before the opening date of the Bid strictly observing the following conditions:-
 - "Contactor's will not write their names or their firms name on this envelops. . The number mentioned on acknowledgement only will be mentioned on the envelope containing original affidavits, DD for Bid cost and earnest money. This is essential to maintain the confidentiality of bidder. Acknowledgement slip will be put inside this envelope to ensure proper identification of the bidder"
- 22. Five year maintenance will be done by the same contractor as per the guide lines.
