

Notice Inviting Tender (No.-RWD/MMGSY (NDB)/HQ/ET/58(R)/2023-24)

Bidding is open to all bidders from eligible source countries as defined in the bidding document.

Departmental Letter No. BRRDA (HQ)-PMGSY-219/2021-3539 (e)/Patna, dated 26.12.2022 will be applicable for all tenders and the earlier notification no.-447(s), dated- 16/01/2020 issued by the Road Construction Department, Government of Bihar, is now deleted. Hence, as per RWD letter no. 1714 dt 24.07.2014, rate quoted below more than 10% of BOQ Cost, their tender will be rejected thereby the tenderer is liable to submit Additional Performance Guarantee for the unbalanced bid in accordance with Clause-26.3 of ITB and Clause-46 Part-1 General Condition of the Standard Bidding Document (SBD).
3. As per letter No.-29 encl. dated: 25.01.2021 issued by Home Department, Government of Bihar and subsequently department letter No.- 489 (e) dated: 29.01.2021, it is mandatory to submit a Character certificate by bidders.
4. LoA will be issued after verification of Bid Security Instrument.

Notice Inviting Tender (No.-RWD/MMGSY (NDB)/HQ/ET/58(R)/2023-24)

SECTION 1

1. The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to qualify for the award of the contract and also inspect the site before bidding.
2. Time allowed for completion of each package is 12 months, including the rainy season. If the size of the package is greater than 10 Crore then Construction / Time of completion shall be enhanced from 12 Months to 18 Months.
3. Earnest money pledged in favour of Executive Engineer of the concerned Division as mentioned in Bihar Financial Rule. For work costing more than one crore, Bank Guarantee from any scheduled bank in the state is applicable (If issued from any scheduled bank outside state then it will be converted to any scheduled bank within the state of Bihar before executing the work agreement).
4. The bids shall remain valid for acceptance for a period of 90(ninety) days from the last date of submission of bids. Bids once submitted cannot be withdrawn. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
5. A set of bidding documents will be available online on website <http://pmgsytendersbih.gov.in>. Cost of bid document as per the amount specified in the Appendix to ITB non-refundable will be deposited in the form of demand draft of any scheduled bank in favor of the Executive Engineer mentioned in column 12 of the table corresponding to the respective package.
6. Bids must be submitted on-line on website <http://pmgsytendersbih.gov.in>
7. Bids submitted on-line must be accompanied with a scanned copy of Demand Draft of bid cost per package as part of Bidder's documents.
8. Instrument of Bid Security (as specified in the bidding document) of the amount specified for the work shall be valid for 45 days beyond the validity of the bid. Scanned copy of the instrument of this affidavit shall be submitted on-line as part of the Bidder's documents.
9. Each bidder is required to furnish an affidavit giving information on prescribed Performa Section-3 Qualification Information of the Bidders required for evaluation of the bidding capacity of the bidder. Scanned copy of this affidavit shall be submitted on-line as part of the Bidder's document.
10. Affidavit (as detailed in point 9 above) along with Original Demand Draft of Cost of Bid Document in the form of DD and Bid Security shall be placed in an envelope and must be submitted at the office of Concerned Chief Engineer, Superintending Engineer & Executive Engineer either by registered post or by hand before dated **16.06.2023** up to **1500 Hours** of the Bid strictly observing the following conditions: -
 - a) Bidder WILL NOT WRITE THEIR NAMES OR THEIR FIRM'S NAME on this envelope.
 - b) When the bidder submits his bid on-line, he will get an acknowledgement of the submitted bid. The number mentioned on this acknowledgement only will be mentioned on the envelope containing original affidavit, DD for Bid cost and earnest money. This is essential to maintain the confidentiality of the bidder.
 - c) A copy of acknowledgement slip will be put inside this envelope to ensure proper identification of the bidder.
11. The date and time of opening of the financial bid shall be notified on website <http://pmgsytendersbih.gov.in> This is conveyed to the bidder automatically through an e-mail message. The Financial bids shall be opened accordingly on-line on the same website <http://pmgsytendersbih.gov.in>. All communication with the bidder will be done through e-mail message.
12. A bidder not be permitted to bid for works in the Circle responsible for awarded an execution of contracts in which his or his spouse's near relatives (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive).

13. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State/Central Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.
14. Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be compiled with by the contractor can be seen in the office of the concerned Executive Engineer mentioned corresponding to the respective package. All these documents can be downloaded from the website <http://pmsgsy tendersbih.gov.in> directly.
15. In evaluation of the bidder's experience, the work done as Sub-contractor shall also be considered as mentioned in Bidding Document.
16. The Department may add or delete any of the condition required for execution of any work.
17. VAT/GST Clearance Certificate will be required before agreement from the Successful Bidder Only
18. Bidder must submit G.S.T Registration in State of Bihar, Power of attorney/Partnership deed/MOU of private limited company at the time of submission of bid.
19. Other details can be seen in the bidding documents.
20. Qualified bidders have to be registered with RWD (if not already registered) before signing of agreement.
21. The undersigned has the right to extend or cancel the tender without assigning any reason.
22. All Documents Submitted by the Bidders with affidavit shall be considered in technical bid evaluation but after award all the documents shall be duly verified.
23. Bidders should have valid registration with Employees Provident Fund organization under EPF and Miscellaneous Act,1952.
