6. Ensure uploading of physical progress with necessary data on MIS before payment .
7. Diversion of Allotment is Strictly Prohibited.
8. All the concerned PIUs are directed to maintain Allotment Register, Road wise Expenditure Register & update the MIS just after Payment made to Contractor.






